Dear Speaker Ryan:

We are writing to respectfully request that you revise the Speaker's policy which currently prohibits Members from making audio or video recordings or taking still photographs on the House Floor as well as allow C-SPAN to control its own camera feed.

Recently House Democrats took to the House Floor as a way to draw attention to the issue of gun violence prevention legislation. Because during much of that time the House was not in session, the only way for the public to see what was happening was through Member use of live video streaming.

C-SPAN cannot control its own cameras, and so it could not provide its normal television coverage. Allowing it to do so would provide the American people a better view of its democracy in action.

Such an interest is clearly present. While one may disagree with the actions of House Democrats, the public demonstrated an overwhelming interest in watching the only available coverage, which had to be provided by these live streams from Members. On one platform alone, Facebook Live, streams were watched over three million times.

This is just one example of the public's appetite for more access to its political leaders. Allowing audio/video recordings and still photographs on the House Floor when the House is in or out of session would be a tremendous way of connecting more people, particularly millennials who so often use this technology, with our democracy. Such recordings and images should only be allowed, however, with the consent of those being covered, for we want Members to be able to feel free to meet and talk on the Floor confidentially.


We understand and respect your obligation to enforce House Rules which require order and decorum. However, what amounts to a violation of order and decorum can and should change with the times. Using smart phones to record and take photographs simply is not in every instance the breach of decorum it once may have been.

We encourage you to allow C-SPAN to control its cameras and to allow Members to conduct audio or video recordings and take still photographs on the House Floor in a way that both maintains the order of the House, respects Member confidentiality, and uses commonplace, modern technology to better connect the American people with the workings of the House.
